

Conditions

PregDesire and the Center for Assisted Reproduction

1. PregDesire

- 1.1. PregDesire provides all necessary information by her website www.pregdesire.eu, by e-mail and telephone.
- 1.2. On arrival in the Czech Republic PregDesire accompanies client to the Spa Resort Klimkovice and the Center for Assisted Reproduction, and assists during the communication between the client and specialist during the first consult, if necessary.
- 1.3. On client's request PregDesire will assist during the continuing communication with the specialist if a language barrier occurs. The costs will be calculated on basis of frequency, duration and cost of transportation.
- 1.4. PregDesire is obliged to remove or destroy all medical information on the client within one month after treatment, whatever the form of information might be.
- 1.5. PregDesire obliges herself not to hand over any information on the client to third parties, except the specialists of the Center and/or the Spa Resort.

2. Liability

- 2.1. The Center, the Spa Resort and PregDesire accept no liability for:
 - 2.1.1. Well-known or unknown side-effects of prescribed medication,
 - 2.1.2. Side-effects of narcosis or the influence of it on the embryo,
 - 2.1.3. The absence or failure of a pregnancy.

3. Questionnaire and Plan of Treatment

- 3.1. Client supplies all required information in the Questionnaire.
- 3.2. If client's physical condition forms an impediment for a successful treatment, the client will immediately be informed.
- 3.3. If there are no impediments to undergo a treatment, client will receive a concept Plan of Treatment including the prescribed medication, time schedule and the conditions.
- 3.4. Separately an Agreement and Invoice will be send.
- 3.5. The implementation of the Plan of Treatment comes into effect on the day on which PregDesire receives the signed Agreement by ordinary mail or e-mail.

4. The egg cell donor

- 4.1. The egg cell donor is aged between 21 and 35, of good health, non-smoker, well educated and intelligent. The Center strives to select a donor with the same length, color of eyes and hair, and blood-group as the recipient. The donor has endured all determined tests.
- 4.2. Neither the Center nor PregDesire accept liability for a child, springing from a succeeded pregnancy, which (partially) doesn't answer to aroused hopes based on paragraph 4.1.
- 4.3. Information about the donor will not be provided. All data concerning the medical condition of the donor, research results and notes of conversations are safely locked up in the Center. Only when the medical condition of the child who originated from donated egg cells requires information, specialists are authorized to consult this information.

5. The sperm

- 5.1. In case fresh sperm is not possible, the sperm can be obtained by means of the MESA/TESE method. If the latter method is not possible, donated sperm from the Center's sperm bank can be used.
- 5.2. Remaining sperm can be frozen for later use. For that purpose client signs a separate Cryopreservation Contract with PregDesire.
- 5.3. Donated sperm comes from a donor aged between 21 and 35, of good health, non-smoker, well educated and intelligent. The Center strives to select a donor with the same length, color of eyes and hair, and blood-group as the husband/partner of the recipient. The donor has endured all determined tests.
- 5.4. Neither the Center nor PregDesire accept liability for a child, springing from a succeeded pregnancy, which (partially) doesn't answer to aroused hopes based on paragraph 5.3.

6. The laboratory

- 6.1. The fertilization of the egg cells takes place in the Center's laboratory under most careful conditions.
- 6.2. The Center and PregDesire don't accept any liability for well-known or unknown complications, a failing cell division, an abnormal development of an embryo, or a technical failure in the laboratory.
- 6.3. Client will be informed about the number of embryos and their quality at the latest on the third day after fertilization.
- 6.4. For each transfer at least 2 embryos are prepared. In case there are not at least 2 embryos of good quality, the transfer will not be carried out.
- 6.5. Remaining embryos can be frozen for later use. For that purpose client signs a separate Cryopreservation Contract with PregDesire.

7. Embryo Transfer

- 7.1. On the 4th or 5th day after fertilization one or two embryos are transferred into the client's uterus. The exact number of embryos will be discussed on beforehand.
- 7.2. The Center and PregDesire don't accept any liability for the common chance on miscarriage, and a raised chance on multiple births.

8. Costs

- 8.1. The invoice comprises the costs connected with the execution of the Plan of Treatment, including medical and technical operations, consultations, medication and narcosis which are necessary for a good course of the treatment at the Center, and including the treatments, consultations, accommodation and meals at the Spa Resort. The nature, number or frequency of the operations, consultations, medication and narcosis don't influence the level of the costs.
- 8.2. If applicable the invoice comprises the costs of transportation to and from the Czech Republic and car renting. PregDesire's mediation costs related to travelling are free of charge.
- 8.3. Other costs, such as travelling to and from the Czech Republic by own car, the costs of transportation between the Spa Resort en the Center v.v., the costs of petrol in case of car rental, costs of partner's consultations and treatment at the Spa Resort, costs connected to the use of the Spa Resort's facilities during leisure time and all other costs which aren't related to the execution of the Plan of Treatment are for client's own account and have to be settled on the spot against the current prices.

- 8.4. Costs for medical and technical operations, consultations, medication and narcosis which are not obtained at the Center are for client's own account.
- 8.5. The prices mentioned on the Invoice are valid one month after the day of issue. After this date has been expired PregDesire will not be held on the prices mentioned in the invoice. If client decides on a later instance to undergo the offered treatment, client will get a new invoice based on the most recent prices.
- 9. Payment and cancellation**
- 9.1. After having sent the undersigned Agreement the client pays a not refundable deposit of 30% within 7 working days on PregDesire's bank account.
- 9.2. The remaining amount needs to be paid at the latest 2 weeks before the day of arrival.
- 9.3. In case the amount is not on PregDesire's account on the day of arrival, PregDesire preserves the right to stop the procedure, not to carry out the Plan of Treatment and will not retribute the deposit as mentioned in paragraph 9.1.
- 9.4. The amount of restitution due to cancelation totals:
- 9.4.1. 95 % of the remaining amount under the condition that the total or remaining amount has been paid, and the cancellation was done 1 week or more before the planned date of arrival.
- 9.4.2. 50 % of the remaining amount under the condition that the total or remaining amount has been paid, and the cancellation was done 6 days or less before the planned date of arrival.

10. Accommodation

- 10.1. The room or the apartment is equipped with satellite-TV and Telephone which has its own outside line. Own bathroom and/with a toilet is at client's disposal.

11. Meals

- 11.1. Meals are prepared according to the norms for diet. It is possible to make a choice of vegetarian menus.

12. Other services

- 12.1. Costs for extra treatments can be paid in cash or by means of Euro card/MasterCard, Visa, Visa Electron and Maestro.

13. Remarks

- 13.1. The room of apartment is available on the day of arrival from 09:00 h and on the day of departure until 08:00 h.
- 13.2. If the client uses medicine on regular base it is needed to hand in a doctor's certificate on client's state of health. If applicable client takes the required quantity for the duration of the stay.
- 13.3. Insurance, medication and medical material are not included in the price.
- 13.4. In case the client is as such needy that assistance is essential for e.g. washing, dressing, shaving, transport by wheelchair, accompany to go to the treatments, etc. the assistance has to be arranged by the client. If the client doesn't arrange anything of the kind, the Spa Resort preserves the right to cancel the stay and treatment.
- 13.5. Dogs and other pets are not allowed to be or stay at the Spa Resort, except guide dogs.
- 13.6. Smoking is only permitted on fort hat purpose designated places.
- 13.7. Partner's treatment is excluded from the price. They can be ordered on the spot. Current prices are applicable.
